LEARNING PLATFORMS IN TEACHING ENGLISH FOR STUDENTS OF NON-LINGUISTIC SPECIALTIES

Global changes in the life of society have a huge impact on the teaching methodology of all disciplines. And teaching English for Students of non-Linguistic specialties is not an exception. The quantity and quality of information required by students is growing steadily, and requirements are changing rapidly. A foreign language has long been considered not as a separate science, but as a necessary element in a complex, multi-level structure of education. Increasingly, the question arises of the need to form a student's professional mobility, ability to switch to another activity successfully or change the type of work.

Teaching English for students of non-linguistic specialties has its own peculiarities. And in the framework of distance learning the teachers and students face new difficulties including, inter alia, the selection of learning platforms. Coursera is the largest educational resource with 143 partners from 28 countries and more than 15 million students. The project collaborates with Princeton, Stanford, Michigan universities.

One of the ways to immerse in the language environment and overcome the language barrier is to communicate with native speakers online. Talking to peer students is one way to practice listening comprehension. Nowadays it is not difficult to find an interlocutor on the Internet, which undoubtedly brings great benefits. Communication with native speakers contributes to the enrichment of students' vocabulary, the development and consolidation of basic grammatical structures, and increases their self-confidence. This is where students can find modern expressions and language constructions, slang that have not yet entered academic dictionaries and textbooks, such as the Interpals website, the Speaky.com language social network, HelloTalk, Tandem applications and others.

In the educational process, one cannot fail to note the need to use e-mail and blogs. E-mail has several advantages over paper. It is faster, more convenient and can be carried out with any audience and at any level of language proficiency, it helps to establish friendship ties.

In modern conditions there are many opportunities for using blogs in the educational process, the records of the author (or authors), which are arranged in chronological order and provided with readers' comments. Blogs are subdivided into text, music, photo, video; can be private or collective. Blogs of famous musicians and actors are very popular among students. Using a blog helps to learn the rhythm and intonation of speech, allows to perceive non-verbal means of communication, which are also important in the communication process. Instagram can also be used effectively in working with students, as it helps to increase motivation. The capabilities of the application are extensive, which allows you to literally be in touch around the clock. The gaming industry is one of the fastest-growing spheres today. In a playful way, information is much easier to remember, both for children and adults. This is the most promising teaching model for modern society.

Based on the little experience gained in the past academic year, some conclusions can be drawn. For example, now teachers are faced not only with difficulties, but also with opportunities to improve their skills in using technology, to learn about various educational platforms, and to use them in their practice, thereby increasing the quality of education and students' motivation.

In our university Platonus platform is used to conduct classes and assess the educational achievements of students. At the same time, the Moodle platform is used, which allows teachers to create tests, video tutorials, set up tasks for completing tasks, and also provides feedback. Also in practice, we use resources such as Microsoft teams, Google classroom, Zoom to conduct classes and final assessment. - 4. Ease of use everything is systematized, does not interfere with perception, does not strain the user.
- 5. Individual approach for each student a special course is developed, which is based on the general plan, but supplemented and modified taking into account the characteristics and needs of the student.
- 6. Comprehensive monitoring of progress on the online platform you can save all the materials passed, all the results of assignments, videos. The student has access to these files and can repeat the desired section of the program at any time. The information received is constantly checked by the teacher, the teacher corrects the student's mistakes in time.
- 7. Implementation of the PBL principle on modern online platforms the problem-based learning method is often used the formulation of a specific problem and its systematic solution.

Despite all the many advantages of distance learning, it also has its disadvantages:

- 1. The process of distance learning is mainly carried out in an independent manner. For this type of learning, it is important to have self-control, good concentration and a clear understanding of the learning objectives.
- 2. In some cases, it is difficult to achieve the concentration of students' attention and keep their attention without having live contact with the student
- 3. Often there may be problems with equipment breakdown, the disappearance of the Internet signal or other technical or human factors.

As a result, the disadvantages, however, are much less than the. Undoubtedly, despite the mentioned advantages distance learning also has its disadvantages, since nothing can replace live human communication. Nevertheless, Internet resources are a powerful tool that helps to assimilate the material and improve the entire educational process as a whole.

In today's world, where computer technology is developing, the Internet is expanding and innovative ways of teaching are improving, it is important not to miss the chance to become a part of these innovations. They will definitely bring benefit and success to the professional growth of teachers, as well as make a significant contribution to the teaching english for students of non-linguistic specialties.
